## ELIGIBILITY REQUIREMENTS

The qualifying thermostat must be installed in a building served with natural gas from Arkansas Oklahoma Gas (AOG). Eligible thermostats include Ecobee and Nest smart WiFi thermostats with automatic scheduling and/or occupancy sensing enabled.

For smart thermostats meeting the requirements listed above, AOG will pay a \$100 rebate. Rebate offer applies only to new thermostats.

Each residential AOG customer is limited to two (2) smart thermostat rebates per household. Commercial facilities may call the number below to check availability. Smart thermostats must be fully installed, operational and connected to the internet via Wi-Fi prior to submitting a rebate application.

Thermostat installation must conform to all applicable building, local and state codes, manufacturer specifications and requirements.

## APPLICATION REQUIREMENTS

The rebate application form must be submitted within 90 days of installation date or postmarked by December 31, whichever comes first.

A complete legible copy of the dated receipt must accompany the completed rebate application and must include the brand and model number.

AOG reserves the right to inspect the installed equipment.

Rebate qualifications and amounts are subject to change. Rebate funds are limited. Completed rebate forms will be processed in the order in which they are received. AOG rebate programs may be canceled or changed at any time.
